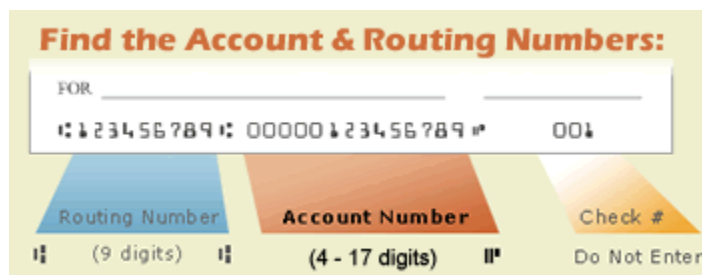

Frequently Asked Questions

When will commission payments be available in my bank account?

Commission payments are deposited directly into the designated bank account by the 6th of each month. If the 6th falls on a weekend, the deposit will be made the following business day.

Will I be notified when money is deposited in my account?

You will not receive a notice each time a payment is deposited to your account. Commission statements are mailed and/or emailed by the 10th of each month. If the 10th falls on a weekend, the statement will be sent the following business day.

Can funds be automatically withdrawn from my account?

No, GeoVera Specialty Insurance Company will not withdraw money from your account. If you have a balance due on the commission statement, you must remit payment to the company.
